#### **Discussion:**

On February 10, 1987 your Board established the Warrant System Trust Fund for monies collected by the imposition of a seven (7) dollar assessment on every person convicted of failing to appear in court pursuant to Penal Code Section 853.7 or Vehicle Code Section 40508, per Assembly Bill 2989. On April 21, 2009 your Board authorized increasing the assessment to fifteen (15) dollars from seven (7) dollars based on the passage of Senate Bill 1754. That legislation also directed that all collected monies be used to develop, modernize, and maintain the automated warrant system and then any remaining balance be used to fund a warrant service task force for the purpose of serving all bench warrants in the county.

The purpose of this letter is to request appropriations totaling \$65,763 with offsetting revenue from the Warrant System Trust Fund to upgrade the automated warrant system that is an integral part of the Ventura County Integrated Justice Information System (VCIJIS). The upgrade is needed to replace aging computer equipment and will result in quicker and more reliable delivery of Warrant System information to users in both the mobile and desktop environments. The proposed upgrade will include the purchase of eight new servers, modem administration software, and one additional server software license.
