DISCUSSION:

COPS funds totaling \$243,614 have been allocated for the District Attorney's Office. Before the Auditor can disburse these funds, COPS legislation (SB 736, 2001) requires your Board to approve a spending plan and certification of the plan's approval by the Supplemental Law Enforcement Oversight Committee (SLEOC). These state funds are being held in trust until such approval and SLEOC review have occurred. (See Gov. Code, § 30061, subds. (a) and (b).) The recommended action is for your Board to approve the spending plan proposed herein so that the Auditor can disburse the funds to the District Attorney after SLEOC certifies receipt of the approved plan and upon presentation of documented expenditures by the District Attorney.

COPS SPENDING PLAN FOR FY 2011/12

The \$243,614 in available COPS funding will be used to combat gang violence, sexual assaults, and homicides by prosecuting such crimes, including death penalty cases. The funds primarily will be used to employ new and existing attorneys to address workload increases in these areas. This plan is consistent with plans from prior fiscal years that were approved by your Board.

Upon your approval of the spending plan, I will request that the \$243,614 in COPS trust funds incorporated into the District Attorney's FY 2011/12 budget be disbursed by the Auditor from the trust account following SLEOC certification and upon my presentation of documented expenditures in conformance with the plan.
