*Because this fund is a capital projects fund, this budget projection includes revenues and expenditures related to fixed assets and excludes the fixed asset contra account (object 4992) and depreciation expense (object 3611) to more closely match revenues to fixed asset outlays.

DISCUSSION:

The Board of Supervisors has previously approved the allocation of Community Development Block Grant funds for the design and construction of a skate park for the community of Piru. With the dissolution of the Piru Redevelopment Agency, it is anticipated that the General Services Agency will be managing the construction. The estimate for completing the skate park is \$932,988. Costs are distributed in accordance with the following:

To date, \$771,684 has been received in Community Development Block Grant funds by the Piru Redevelopment Agency for the project, of which Board of Supervisors Apply for Grant HRP April 24, 2012 Page 3

\$280,218 has been expended for preconstruction design, CEQA compliance, permits and plan check. The balance of \$491,466 of Community Development Block Grant funds remains available for construction of the skate park.

The grant proposal for the Housing Related Parks (HRP) Program is requesting a \$161,400 contribution for the completion of the Piru Skate Park project. The HRP program is administered by the Department of Housing and Community Development. There is no matching contribution for this grant. Proposed funding for the construction and design portions is as follows:

There is no anticipated additional Agency or County indirect cost associated with meeting the grant requirements. Plans and specifications are currently under preparation. The work activities will continue through FY12-13.

At the time of this writing the DHCD has not awarded the grant and has therefore not submitted a grant agreement. However, a copy of DHCD's grant Standard Agreement attached as Exhibit 3 will be reviewed and approved by County Counsel before it is signed.
