Discussion:

Presented to your Board today is the renewal of contracts for the continued operation of Fillmore Family Medical Group and Piru Family Medical Center, operated by Christine Johnston, M.D., Pediatric Diagnostic Center, operated by Christopher Landon, M.D., Santa Paula Hospital Clinic and Santa Paula West, operated by Lisa Solinas, M.D., and Santa Paula Medical Clinic, operated by Connell Davis, M.D. Each contract allows for up to \$1,000,000 maximum annual operating capital to be paid in any year of operation. The initial contract provisions allowed for four extensions following the initial 12 months of operation, bringing its expiration through June 30, 2012.

The Ventura County Medical Center Department of Ambulatory Care affiliated clinics provide quality, compassionate, and comprehensive health care and medical treatment services at strategically placed neighborhood clinics throughout Ventura County. These clinics provide a continuum of care from infants to the elderly, from generalized family care to specialized services, by exceptionally qualified and committed Board Certified physicians. The clinic contracts presented for renewal facilitate access to care for those in need.

These agreements shall be effective July 1, 2012, and subject to all necessary budgetary approvals by the Ventura County Board of Supervisors, shall remain in effect until June 30, 2013. Then, unless either party gives notice of its intent not to renew at least thirty (30) days prior to the renewal date, and subject to the receipt of all necessary budgetary approvals by the Ventura County Board of Supervisors, each agreement shall then be extended for up to four (4) additional periods of one (1) year each. The costs of these contracts are included in the current budget.
