<u>Subject</u>: Approve the Plans and Specifications for the Camarillo Airport 295 Durley Avenue Building Improvements, Including Addendum 1; Waive Any Minor Irregularities in the Bids; Delegate Authority to the Director of Airports, or His Designee, to Award a Contract to Damon, Inc. of Downey, CA on the Basis of the Lowest Responsible Bid in the amount of \$74,454, Conditioned Upon the Execution of a Long-Term Lease Agreement Between the County and the State of California for the Building Located at 295 Durley Avenue; and Authorize the Director of Airports, or His Designee, to Execute the Subject Contract; Find the Project Is Categorically Exempt from California Environmental Quality Act (CEQA); and Authorize the Director of Airports to Record a Notice of Exemption. Recommendations

Staff recommends that your Board:

- 1. Approve the plans and specifications for the Camarillo Airport 295 Durley Avenue Building Improvements (Exhibit 1), including Addendum 1 (Exhibit 2);
- 2. Waive any minor irregularities in the bids;
- 3. Delegate authority to the Director of Airports, or his designee, to award a contract (Exhibit 3) to Damon, Inc. of Downey, CA on the basis of the lowest responsible bid in the amount of \$74,454, for which funds are available in the Airport Enterprise Fund (AEF), Budget Account 7342-4033, conditioned upon the execution of a long-term lease agreement between the County and the State of California for the building located at 295 Durley Avenue;
- 4. Authorize the Director of Airports, or his designee, to execute the subject contract;
- 5. Find the project is categorically exempt from CEQA and authorize the Director of Airports to record a Notice of Exemption.

DISCUSSION

The Department of Airports and the State of California are in negotiations for the long-term lease of the building located at 295 Durley Avenue at the Camarillo Airport. The State of California Food & Agriculture currently occupies the building on a month-to-month basis, but wishes to secure the premises for a longer term. During negotiations, the State identified the need for certain ADA improvements, as well as the addition of a "Bait Room" in order to meet operational requirements.

This Contract is for those identified ADA improvements needed, as well as the addition of a "Bait Room." The project will be funded by the Airport Enterprise Fund, with the cost of the "Bait Room" design and construction repaid through the term of the lease in the form of a negotiated higher rental rate. The award of contract is conditioned upon the execution of a long-term lease agreement between the County and the State of California for the building located at 295 Durley Avenue.

Specifically, the ADA improvements include adjustments to or replacement of restroom/breakroom fixtures, handicapped parking stalls, signs, paths of travel, and certain door modifications. The "Bait Room" work includes the installation of a ventilation hood, floor drain, utility sink, fan, and other improvements. The Engineer's estimate for all work is \$64,971.

Bids for the project were opened on November 20, 2012. A copy of the bid abstract for the three (3) bids received is enclosed as Exhibit 5. The bids have been reviewed for form. Damon Inc. of Downey, CA submitted the lowest responsible bid in the amount of \$74,454. The low bid is 14.6% over the engineer's estimate of \$64,971. We believe that the bid reflects the value of work to be done.

This project is categorically exempt under the CEQA Guidelines, because it consists of the installation of small new equipment in small existing structures which do not involve the use of significant amounts of hazardous substances, and where only minor modifications would be made to the exterior, and minor alterations, reconstruction, or replacement of existing facilities that does not involve change or expansion of the existing use. (See Cal. Cod Regs., tit. 14, §§ 15301 [Class 1 exemption], 15302 [Class 2 exemption], 15303 [Class 3 exemption].) None of the exceptions in Section 15300.2 of the CEQA Guidelines apply.

Therefore, we are asking the Board to delegate authority to the Director of Airports, or his designee, to award a contract in the amount of \$74,454 on the basis of the lowest responsive and responsible bidder, conditioned upon the execution of a long-term lease agreement between the County and the State of California for the building located at 295 Durley Avenue; and also authorize the Director of Airports, or his designee, to execute the contract for the subject project.
