The Addendum requires the City of Ojai to obtain approval for any new volunteer entities that require oversight by the Sheriff's Office. In addition, all volunteers will be required to provide evidence of a medical insurance program and sign a waiver form. Volunteers are considered a city or county volunteer based on which entity (city or county) the services provided will benefit.

As stated in section 10 of the Addendum, "This Addendum is intended to supplement the Agreement and shall not be construed to supersede or repeal any provisions of the Agreement".
