<u>SUBJECT</u>

Approval of, and Authorization for the Purchasing Agent or Designee to Sign, a Supplemental Nurse Staffing Agreement with XPRT Staffing, Inc., for Temporary Nursing Staffing Services; Authorization for the Purchasing Agent or Designee to Increase or Decrease the Individual Contract Amounts for Specified Nurse Registries as Needed, Provided that the Aggregate Amount Paid for Temporary Nurse Staffing Services Does Not Exceed \$5,700,000 in FY 2022-23.

RECOMMENDATIONS

- That your Board approve, and authorize the Purchasing Agent or designee to sign, a supplemental nurse staffing agreement with XPRT Staffing, Inc. (XPRT) (Exhibit 1) for temporary nursing staffing services.
- 2. That your Board authorize the Purchasing Agent or designee to increase or decrease the individual contract amounts for the specified nurse registries as needed, provided that the aggregate amount paid for temporary nurse services does not exceed \$5,700,000 for FY 2022-23 (Table 1). There is no fiscal change with this recommendation.
