### **Discussion**

# Sales Order OPT-0340459

In October 2019, Ventura County Medical Center's (VCMC) Cerner Electronic Health Record (EHR) performed a system upgrade and a third-party validation of the blood bank system. The third-party, BC Solutions, identified problems relating to label verification of modified blood components. The greatest issue was that the system did not require label verification of modified blood products prior to dispensing to patients for transfusion. This created a potential patient safety issue.

Earlier this year, VCMC lab installed this equipment, and this sales order is the purchase of a blood bank labeling equipment, the installation and five-year maintenance for Santa Paula Hospital lab. It is effective on August 1, 2022. The estimated total cost of the sales order including shipping, handling and sales tax is \$14,705.

### Sales order OPT-0344333

This sales order provides professional services to configure and implement both hospital quality reporting services and eligible provider quality reporting as well as a mandatory licensing subscription for regulatory reporting for the 2022 and 2023 measurement years. Hospital eCQMs (2023) and Core Measures are included in the services. The total cost is \$612,693.
