Change Category: County Requested

Reason for Change: County requests to add TriZetto® QNXT™ Pricing Data Extract Process and the TriZetto Machine Readable File Adapter to the AHS Services.

Description: Pursuant to Section 4.5 (Change Process) of the Agreement, County and Cognizant mutually agree that the AHS SOW shall be amended as follows:

- 1. Section 1 (Definitions) shall be amended by deleting the definition of County-Requested Software in Section 1.3 and replacing it with the following:
- "1.3 "County-Requested Software" means the software listed in Section 2 AMS Services and Scope of Work Limits under "County-Requested Software." County-Requested Software may include (a) third-party products purchased by County, TriZetto-provided third-party products that Cognizant does not routinely host for its clients, and/or (b) Countydeveloped or third-party developed custom interfaces, extracts, applications or stored procedures and/or (c) Cognizantdeveloped custom interfaces, extracts, applications, stored procedures or Utilities that are not covered by Maintenance Services."
- 2. Section 1 (Definitions) shall additionally be amended by adding the following definition:
- "1.28 "TriZetto® QNXT™ Pricing Data Extract Process" means the process used to generate in-network and out of network provider rates from QNXT in support machine-readable file generation."
- 3. Table 2.1.3 in Section 2 (Scope of Work) shall be amended to add the TriZetto® Machine Readable File Adapter (both In-Network and Out-of-Network) as County-Requested Software in a single Non-Production Environment.
- 4. Section 2.2.7.a (Upgrade Services for County-Requested Software) will be added to Section 2.2 (Application Management Services) as follows:
 - "2.2.7.a Upgrade Services for County-Requested Software. Section 2.2.6 (Application Update Services) and Section 2.2.7 (Application Upgrades Services) are not applicable to County-Requested Software. Unless provided for in a separate statement of work, County will be responsible for paying for all update or upgrade Services related to the TriZetto® Machine Readable File Adapter on a time and materials basis."
- 5. Section 2.2.17 will be added to Section 2.2 (Application Management Services) as follows:
- "2.2.17 TriZetto QNXT Pricing Data Extract Process Support Services. Cognizant will support the QNXT Pricing Data Extract Process. The parties will perform their respective responsibilities as set forth in Table 2.2.17 below. County is solely responsible for ensuring its compliance with the Federal Transparency in Coverage [CMS-9915-F] regulations, including but not limited to, the format, content and accuracy of required data and timeliness of file posting. Similarly, County is solely responsible for generating and making publicly available the machine-readable files

- 8. The following Section 3.2.1.d (TriZetto Machine Readable File Adapter) will be added to Section 3.2.1 (Availability Levels):
 - "d. TriZetto Machine Readable File Adapter.
 - i. Service Level. The servers running the TriZetto Machine Readable File Adapter will be available ninety-nine percent (99%) of the time on a 24x7 basis.
 - Calculation. Monthly as a percentage. The numerator is calculated by subtracting the total time the servers running the TriZetto Machine Readable File Adapter are unavailable from the total time in the month on a 24x7 basis. The denominator is the total time in the month on a 24x7 basis.
- 9. Section 3.6.7 will be added to Section 3.6 (Service Level Exceptions) as follows:
- "3.6.7 The TriZetto® QNXT™ Pricing Data Extract Process is not subject to any SLAs. Further, any standard SLA misses caused by the QNXT Pricing Data Extract Process will not be eligible for payment during the first three months following its initial implementation in production. If the QNXT Pricing Data Extract Process creates ongoing issues in the Production environment, it may need to be run in an alternative Environment and additional charges may be required."
- 10. Section 7 (County Responsibilities) will be amended by adding the following:
- "7.10 Unless provided for in a separate statement of work, assume responsibility for providing a resolution for each Incident relating to County-Requested Software."

Fees for the additional AHS Services described in this CRF#4 will be set forth in an amendment to the Software and Pricing Exhibit to the Agreement.

This CRF#4 is contingent upon execution of both this CRF#4 and the Amendment to the Master Software License and Services Agreement Amending the Software and Pricing Exhibit to the Agreement adding pricing for the TriZetto® Machine Readable File Adapter (the "Amendment").
