

RESOLUTION NO. 22-140

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA ESTABLISHING TWENTY-NINE REGULAR FULL-TIME POSITIONS AND DELETION OF SEVEN POSITION ALLOCATIONS IN THE VENTURA COUNTY PUBLIC HEALTH DEPARTMENT

WHEREAS, Ventura County Personnel Rules and Regulations sections 903 and 2701 provide that the number of County positions must be established by resolution of the Board of Supervisors; and

WHEREAS, the Ventura County Public Health Department (PH) has identified and requested the establishment of twenty-nine (29) regular full-time positions in Budget Units 3091, 3103, 3105, 3109, and 3111 and the deletion of three (3) regular full-time positions in Budget Unit 3120 and four (4) fixed-term positions in Budget Unit 3113;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA that the following twenty-nine (29) regular full-time positions shall be established within the units indicated, effective July 24, 2022 and the following seven (7) vacant positions shall be deleted within the units indicated, effective July 24, 2022:
