

RESOLUTION NO. 22-155

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA RATIFYING CHAPTER 5, SECTION 507, CHAPTER 9, SECTION 903, AND APPENDIX B OF VENTURA COUNTY FIRE PROTECTION DISTRICT ORDINANCE NO. 32 PERTAINING TO BUILDING AND FIRE CODE STANDARDS FOR APPLICATION WITHIN THE UNINCORPORATED TERRITORY OF THE COUNTY OF VENTURA

WHEREAS, the unincorporated territory of the County of Ventura lies within the Ventura County Fire Protection District; and

WHEREAS, the Ventura County Fire Protection District has responsibility for fire protection within said unincorporated territory; and

WHEREAS, the Ventura County Fire Protection District did on October 11, 2022, adopt Fire Protection District Ordinance No. 32, adopting the 2022 California Fire Code (CFC), portions of the 2021 edition of the International Fire Code (IFC), portions of California Code of Regulations Title 19, together with portions of the Appendix Chapters thereof, and amendments thereto, and incorporating by reference Ventura County Fire Protection District Ordinance No. 29; and

WHEREAS, Chapter 5, Section 507, Chapter 9, Section 903, and Appendix B of Fire Protection District Ordinance No. 32 contain amendments to building and fire code standards relating to fire and panic safety adopted by the State Fire Marshal and contained in the California Building Standards and Fire Codes; and

WHEREAS, pursuant to Section 13869.7 of the California Health and Safety Code, amendments containing such building standards are not effective within the unincorporated territory of the County until Chapter 5, Section 507, Chapter 9, Section 903, and Appendix B of Fire Protection District Ordinance No. 32 are ratified by the Board of Supervisors; and

WHEREAS, Chapter 5, Section 507, and Appendix B of Fire Protection District Ordinance No. 32 contains similar building and fire code standards to those that have been in effect and enforced within the County since January 1992; and

WHEREAS, Chapter 9, Section 903 of Fire Protection District Ordinance No. 32 contains similar building and fire code standards to those that have been in effect and enforced within the County since June 3, 1982; and

WHEREAS, the building standards contained within Chapter 5, Section 507, Chapter 9, Section 903, and Appendix B of Fire Protection District Ordinance No. 32 are an integral part of the Ventura County Fire Protection District's fire protection response plan;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Ventura ratifies without modification Chapter 5, Section 507, Chapter 9, Section 903, and Appendix B of Ventura County Fire Protection District Ordinance No. 32, to be effective within the unincorporated territory of the County of Ventura on and after its effective date.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Clerk of the Board shall transmit this Resolution to the Fire Protection District within 15 days of its adoption.

Upon motion of Supervisor Parks, seconded by Supervisor Lavere, and duly carried, the Board hereby approves and adopts this resolution on the 11th day of October, 2022.
