

FOURTH AMENDMENT TO THE AGREEMENT WITH MAXIM HEALTHCARE SERVICES, INC. FOR MEDICAL PERSONNEL RECRUITING SERVICES

This Fourth Amendment to the Agreement with Maxim Healthcare Services, Inc. for Medical Personnel Recruiting Services, which became effective July 1, 2017, is made and entered into by and between the COUNTY OF VENTURA, acting through its Behavioral Health Department, a primary service provider, hereinafter referred to as "COUNTY," and MAXIM HEALTHCARE SERVICES, INC. hereinafter referred to as "CONTRACTOR."

The parties hereby agree that the Agreement is amended as follows:

I. Effective with respect to the service period of July 1, 2018 through June 30, 2019, Exhibit "B" (Payment Terms), Sections A and B, shall be modified to read as follows:

A. The maximum amount of this Agreement shall be increased from \$1,346,765 to \$1,746,765 (an increase of \$400,000), for the service period of July 1, 2018 through June 30, 2019.

B. FEES/RATES

CONTRACTOR shall be paid per the following rate schedule for services rendered:
