- 2. Approval of the reappointment of Sandra Tovar to the VCHCP Standing Committee effective December 31, 2018 and ending December 31, 2021.

DISCUSSION:

As part of the initial Knox-Keene Act licensure process, your Board approved and authorized formation of the VCHCP Standing Committee to meet Knox-Keene Act public policy requirements, with authority to oversee the quality of care review system and grievance process. The VCHCP Standing Committee meets quarterly. The VCHCP Standing Committee is comprised of the following as members:

1. Required by Licensure

a. Ex Officio members (by virtue of office):

• A member of the Board of Supervisors, who serves as Chair. Supervisor Steve Bennett currently serves as Chairman of the committee.

- The Ventura County Executive Officer.
- b. Appointed by the Board:
 - One plan provider
 - Four plan members
- 2. In addition, the Standing Committee includes:
 - a. One plan provider member
 - b. Three plan member alternates.

The Knox-Keene Act requires that all members of the Standing Committee be members of VCHCP. Steve Carroll and Sandy Tovar are County employees and VCHCP members. Both work for the Health Care Agency and bring a wealth of knowledge and diverse experience.
