Discussion:

On October 17, 2017, your Board approved the purchase of 22.147 acres of land from Ventura County Community College District in the City of Camarillo where the Fire District's existing training center is located. The Fire District had been leasing the space since 1994. With the purchase, the Fire District would like to move forward with master planning of the site to create a new headquarters facility and a state-of-the-art training center.

Public Works Agency (PWA) sought to engage the services of a consultant to perform needs assessments, programming, master planning, conceptual design, architecture and engineering design, preparation of plans and specifications and construction administration for the new headquarters facility and training center.

PWA began this process by identifying over twenty potential architectural consultants and inviting them to submit Statements of Qualifications (SOQ) for the project. Five SOQ's were received on May 3, 2018, each representing a team of two main consultants; an architect and a training center specialist. SOQ's were reviewed by a selection committee consisting of representatives from PWA and the Fire District. All five respondents were invited to oral interviews which were conducted on May 23, 2018. The selection committee selected the top two respondents following the initial interview.

The top two respondents were invited to a final interview on September 6, 2018 with an expanded selection committee that included representatives from executive leadership of the Fire District, County Executive Office, and PWA. The committee selected the team of Mary McGrath Architects and Manns Woodward Studios as the best qualified consultant team for this project.

The project is still in the early stages, with the entire project requirements yet to be defined. The consultant will help define these parameters by performing various preliminary studies including site water use, sewer connection, site drainage, traffic analysis and exiting utility coordination.

The first phase of the contract includes services up to a conceptual design level with a detailed cost estimate. When these tasks are completed, the Fire District and PWA will present the conceptual design to your Board and request approval to proceed with the project and a corresponding amendment to the consultant contract. At that time, staff will also identify project funding and request approval of the appropriate CEQA document.

PWA requests that the consultant services contract (Exhibit 1) be approved by your Board. The contract has been negotiated with Mary McGrath Architects of Oakland, CA in accordance with the policy adopted by your Board on November 3, 1998. The contract is on a standard form previously reviewed by County Counsel.

The preliminary estimated project costs are as follows:

Soft Costs (including planning, design, permitting, management, etc.):	\$ 10,000,000
Construction (including contingencies):	\$ 30,000,000
TOTAL	\$ 40,000,000
