## Recommendations:

- 1) That your Board approve, and authorize the Health Care Agency (HCA) Director or designee to sign, the attached amendment No. 15 to the Amended and Restated Hospital Services Agreement (Hospital Agreement) (Exhibit 1) with Gold Coast Health Plan (GCHP) for health care services, effective December 31, 2022, extending the Hospital Agreement through June 30, 2023.
- 2) That your Board approve, and authorize the HCA Director or designee to sign, the attached amendment No. 16 to the Amended and Restated Medical Services Agreement – Primary Care Physician (PCP Agreement) (Exhibit 2) with GCHP for health care services, effective December 31, 2022, extending the PCP Agreement through June 30, 2023.
- 3) That your Board approve, and authorize the HCA Director or designee to sign, the attached amendment No. 15 to the Amended and Restated Medical Services Agreement Specialist Physician (Specialist Agreement) (Exhibit 3) with GCHP for health care services, effective December 31, 2022, extending the Specialist Agreement through June 30, 2023.

Sufficient revenue and appropriations are included in the FY 22-23 adopted budget. The operational income includes "Operating Transfers In" that are primarily attributed to County contribution.

## Discussion:

GCHP is a county organized health system governed by the Ventura County Medi-Cal Managed Care Commission, currently serving more than 190,000 Medi-Cal beneficiaries living in Ventura County.

In June of 2018, your Board approved an amended and restated Hospital Agreement, Specialist Agreement, and PCP Agreement with GCHP. The amendments to the Hospital Agreement, PCP Agreement and Specialist Agreement before your Board today will extend the existing agreements through June 30, 2023.

During the extension period, HCA and GCHP will seek to conclude negotiation on agreements that support the long-term health of both entities and all our patients and that align with the ongoing changes to the public health care system funding environment.

The portions of the agreement concerning compensation paid to HCA are exempt from disclosure under the Public Records Act (Health and Safety Code Section 1457 (c) (1)).
