SUBJECT

Authorization for the Purchasing Agent or Designee to Increase or Decrease the Individual Contract Amounts for Specified Clinical Laboratory Registries as Needed, Provided that the Aggregate Amount Paid for Temporary Clinical Laboratory Staffing Services Does Not Exceed \$1,300,000 in FY 2022-23.

RECOMMENDATION

That your Board authorize the Purchasing Agent or designee to increase or decrease the individual contract amounts for the specified clinical laboratory registries as needed, provided that the aggregate amount paid for temporary clinical laboratory staffing services does not exceed \$1,300,000 for FY 2022-23 (Table 1).

Sufficient revenue and appropriations are included in the FY 22-23 adopted budget. The operational income includes "Operating Transfers In" that are primarily attributed to County contribution.

DISCUSSION

The Health Care Agency (HCA) uses registries to fill short-term staffing shortages, provide additional support for staffing fluctuations, and help ease the burden of difficult-to-fill clinical laboratory positions. Clinical laboratory staffing services vendors can fill these sudden and short-term vacancies more easily than HCA, which prevents gaps in staffing and services.

Because HCA contracts with a number of different clinical laboratory staffing services vendors to ensure open requests are filled more quickly, HCA is requesting that the Purchasing Agent continue to be authorized to reallocate funds as needed among the vendors listed in Table No. 1 with an aggregate FY 2022-23 amount for all agreements not to exceed \$1,300,000, a \$200,000 increase. The proposed amounts are offset by revenues that individual departments generate, and appropriations are included in the FY 2022-23 proposed budget.
