For Her Outstanding Service on the Ventura County Planning Commission

WHEREAS, *Nora Aidukas has dedicated nearly two decades of outstanding service representing the Second District on the Ventura County Planning Commission from February 2003 through December 2022; and*

WHEREAS, *her diligent participation in the Planning Commission's work on issues that directly impact the lives of Ventura County residents has included serving as Chair in 2006, 2011, 2016, and 2019; and*

WHEREAS, *throughout her tenure Commissioner Aidukas exemplified the highest qualities of a Planning Commissioner, encouraging effective public hearings by prioritizing public input and actively listening, and maintaining Commission decorum and respectful communication between the Commission, applicant, and the public; and*

WHEREAS, *Commissioner Aidukas prized the excellent work of staff and thoroughly considered their recommendations in making her sound and sensible planning decisions that were sensitive to the needs of communities and with a vision for a healthy future; and*

WHEREAS, *Commissioner Aidukas worked on three cycles of the Housing Element Updates, the Habitat Connectivity and Wildlife Corridor Overlay Zone, the Local Coastal Program amendment for Environmentally Sensitive Habitat Areas, the adoption of the Saticoy Area Plan and development code, and regulations for Dark Skies in Ojai Valley and the Santa Monica Mountains, Outdoor Event Venues, Landscaping, Accessory Dwelling Units, and Agricultural Worker Housing, and reviewed and made decisions on hundreds of private development applications, always with an eye towards what is best for the community, the environment, and the future of the County; and*

WHEREAS, *Commissioner Aidukas played a significant lead role in crafting the Vision Statement of the 2040 General Plan, clearly expressing our County's aspirational goals; and*

WHEREAS, *Commissioner Aidukas has contributed in crucial ways that have enhanced the quality of life enjoyed by Ventura County residents;*
