Re: Notice of Mass Layoff

Dear Recipient:

This letter is to notify you of upcoming changes at Zume, Inc. (the "Company") that may constitute a "mass layoff" as defined by the federal Worker Adjustment Retraining and Notification ("WARN") Act, and/or the California counterpart statute, Cal. Labor Code § 1400 *et seq* ("Cal-WARN"). These changes impact employees working at 151 Factory Stores Dr., Camarillo, CA 93010 (the "Facility"), in addition to the Company's remote workers.

The layoffs at this Facility are expected to occur on or around January 28, 2023. Impacted Facility employees are being provided with 60-days' advance notice of termination.

This layoff is permanent and will impact approximately 61 employees at the Facility. This will not result in a closure of the entire Facility. None of the affected employees are unionized and there exist no bumping rights applicable to these layoffs.

This layoff is expected to impact the following job titles (with parentheticals reflecting the number of individuals in each role):

We are providing you with this notice based upon the best information available to us at this time. We believe that this notice fully complies with any applicable WARN or Cal-WARN requirements, and do not plan to provide you future notices with respect to any incremental changes regarding loss of employment at the Facility. We wish to provide you with notices that are helpful, rather than inundate you with repeated or intermittent updates.
