RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
COUNTY OF VENTURA

**RESOLUTION CREATING AND DESIGNATING FARMLAND  
SECURITY ZONE AREA**

**WHEREAS**, on December 6 and 13, 2022, the Ventura County Board of Supervisors ("Board") held a legally noticed public hearing regarding, among other things, the County of Ventura's proposed approval of new Farmland Security Zone Area ("FSZA")/Land Conservation Act ("LCA") contracts referred to as FSZA/LCA contract numbers 51-5:57.1 and 53-2:16.1;

**WHEREAS**, the LCA and the Ventura County LCA Guidelines require the Board to create and designate land as an FSZA in order for the land to be eligible for a FSZA/LCA contract;

**WHEREAS**, the County published a notice of the December 6, 2022, public hearing pursuant to Government Code sections 51230 and 6061;

**WHEREAS**, the County provided written notice of the December 6, 2022, public hearing to the Ventura County Local Agency Formation Commission pursuant to Government Code section 51233;

**WHEREAS**, the County approved FSZA/LCA contract number 51-5:57.1 on December 6, 2022, but denied FSZA/LCA contract number 53-2:16.1 on December 13, 2022;

**NOW, THEREFORE, BE IT RESOLVED** the Board finds that the proposed creation and designation of one new FSZA on the land subject to the following proposed FSZA/LCA contract, as such land is more particularly described below and on the map attached hereto and incorporated herein by this reference, complies with the LCA (including but not limited to Government Code sections 51296.1 and 51230) and the Ventura County Land Conservation Act Guidelines:

- (1) FSZA/LCA Contract No. 51-5:57.1 covering Ventura County Assessor Parcel Nos. ("APN") 109-0-032-145 and 109-0-032-135
