Fire District Ordinance No. 32, 2022 Ventura County Fire Code

DISCUSSION:

The 2022 Ventura County Fire Code was adopted by the Ventura County Fire Protection District's (Fire District) Board of Directors on October 11, 2022 and becomes effective on January 1, 2023. Since the date of adoption, some typographical errors and an omission in the document have been identified.

This errata notice is being issued administratively by the Ventura County Fire Protection District in order to address nonsubstantive, omission and typographical errors in the numbering of certain sections of the Fire District Ordinance No. 32, known as the 2022 Ventura County Fire Code. The errata renumbers those incorrectly numbered sections and inserts the omission. These are nonregulatory corrections that do not differ substantively from the official ordinance adopted by the Board of Directors.

A summary of the corrected code sections numbers are attached to this notice.
