Standby Premium Pay for Diagnostic Shifts. Client will pay for “scheduled/formal standby” hours, defined as hours where the Staff is not required to stay on the facility's premises, at the rate of \$9.00 per hour. If Staff is called back to work for Client while serving in a “scheduled/formal standby” capacity, the “scheduled/formal standby” charge will cease, and Client will instead pay Contractor the applicable rate for the duration of the call-back period. The minimum call-back period is two (2) hours. No Staff shall be paid for call-back time and “scheduled/formal standby” simultaneously. There is no “volunteer standby” status. Call-back Premium Pay will be one and one-half (1.5) times the regular rate.
