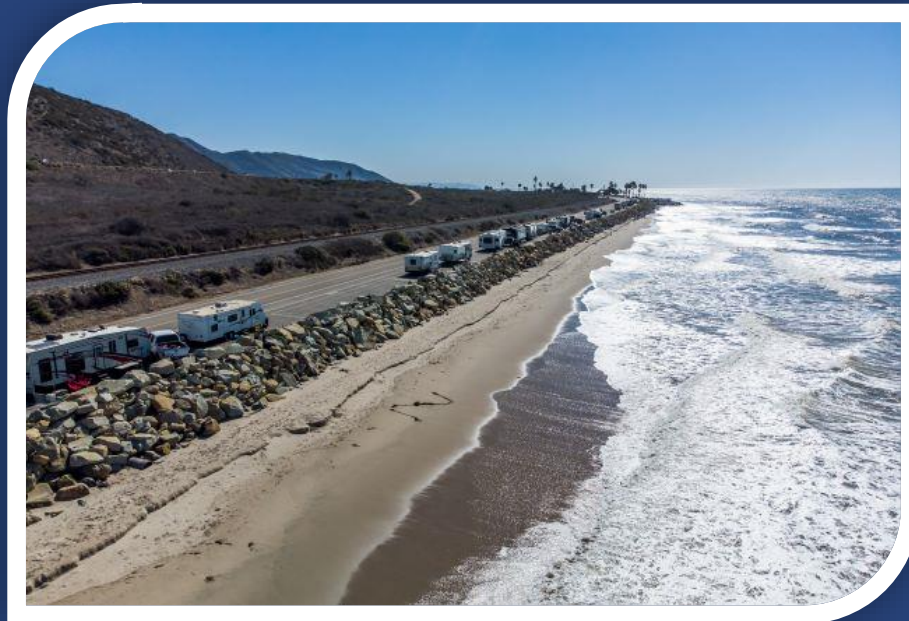

# Parks Department

- Annual O & M budget: \$6.4M
- Enterprise Fund
- 15 regional parks (466 camping spaces)
- 1 leased park (Steckel KOA)
- 4 regional trails
- 6 local parks and 1 skate park
- 3 leased golf courses
- 5 community centers
- 3 historic properties
- 5,321 acres and 23.25 miles of trails
- Staff: 5 Admin, 7 Park Rangers, 10 Maintenance Workers

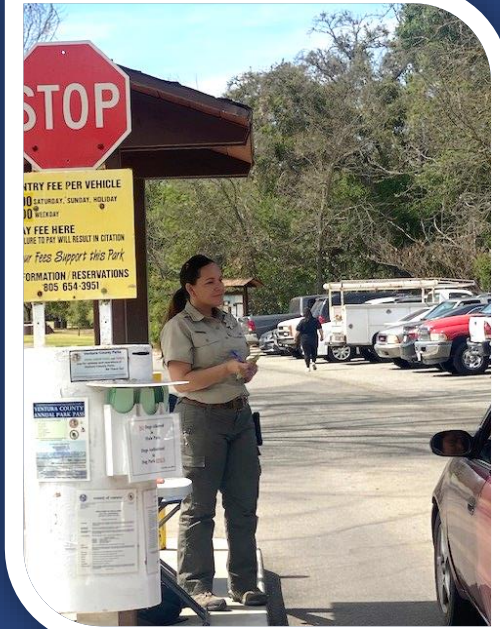
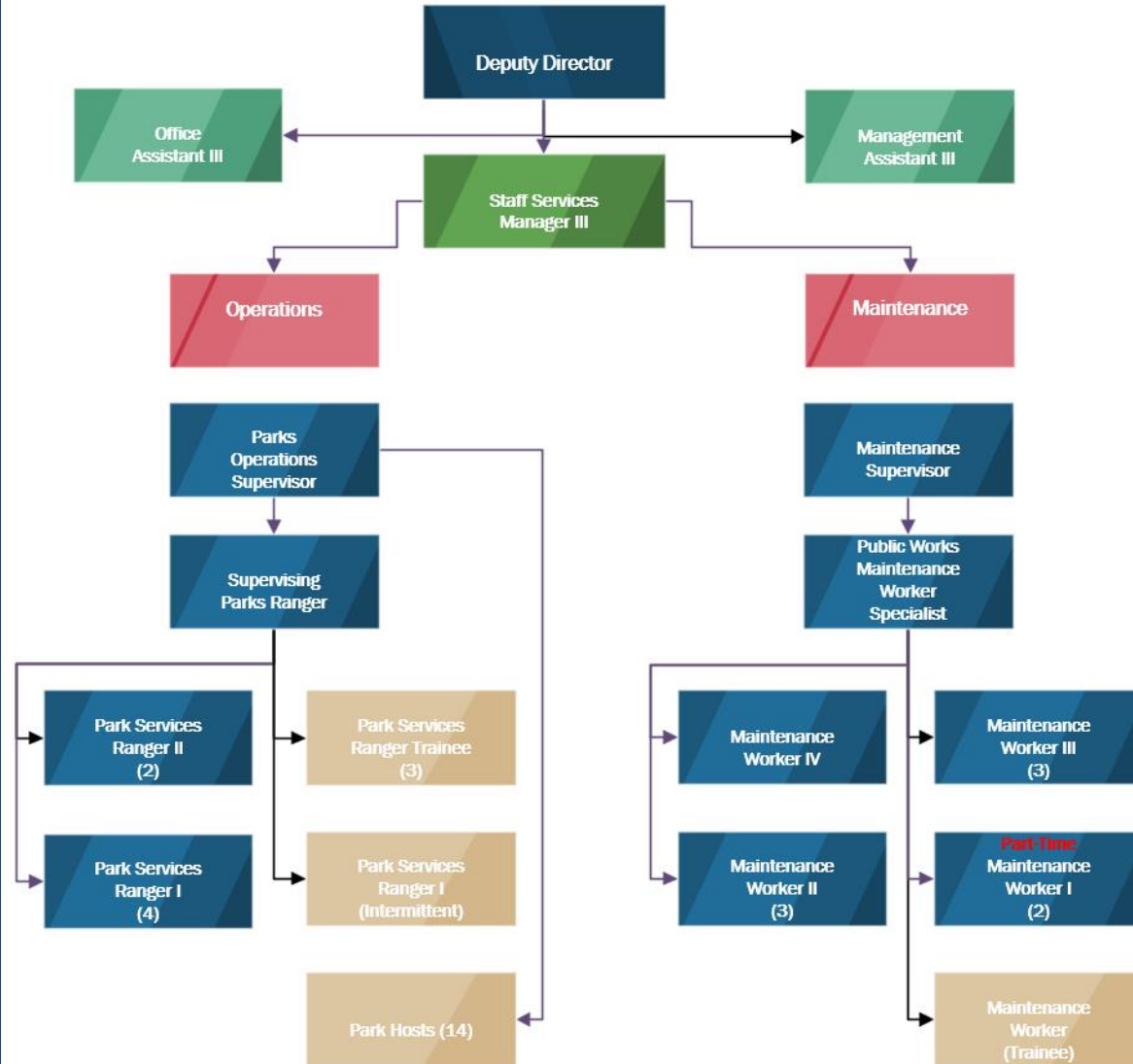

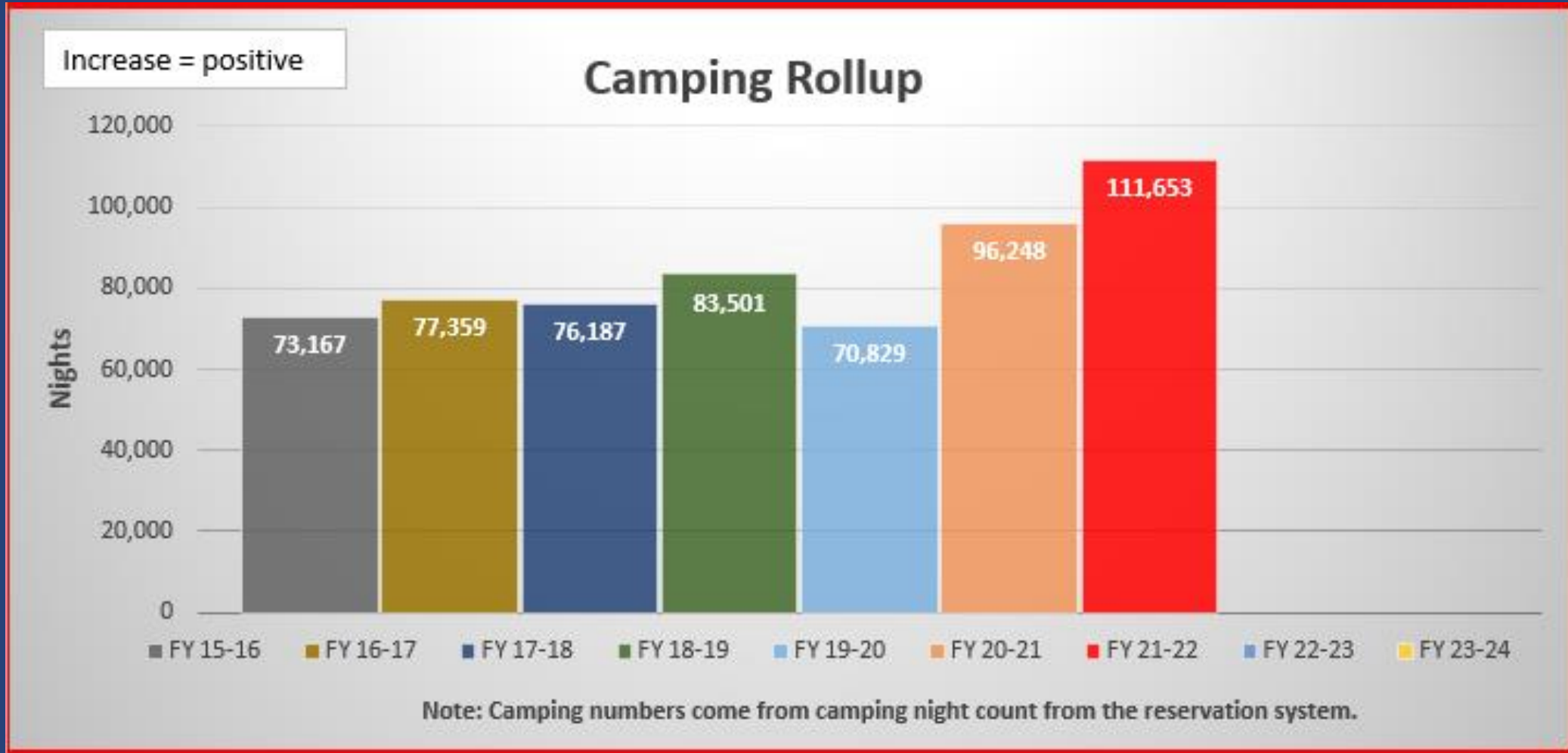

# Camping Use Numbers

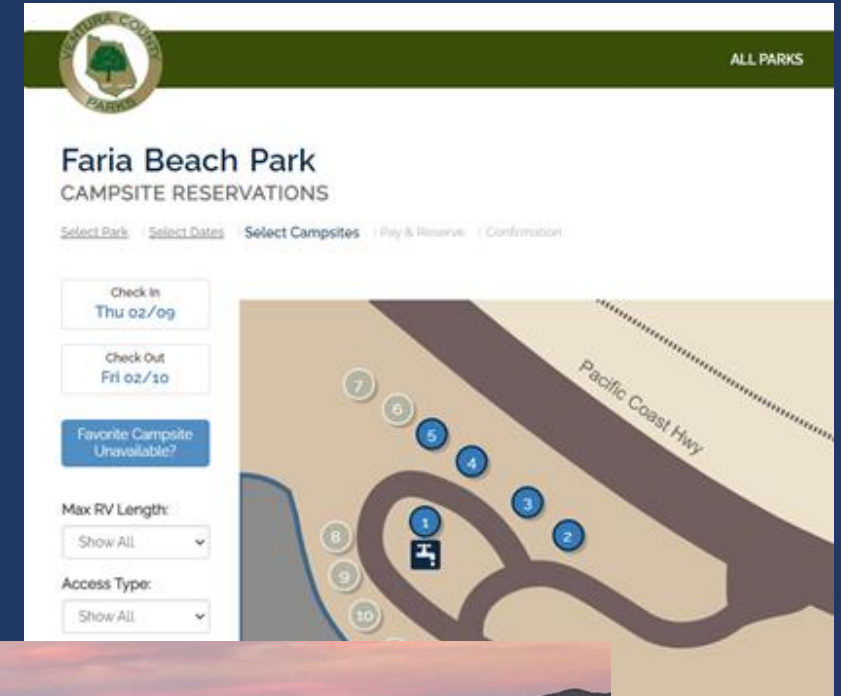


Note: Camping numbers come from camping night count from the reservation system.



# Recent Notable Accomplishments

- New Reservation System and Business Software
- Rincon Beautification Project – Phase I Seawall Mural
- Grants and Supplemental Funding:
  - Nyeland Acres Community Center \$10M
  - Saticoy Park \$5M
  - Oak Park Campground - \$1.7M
  - Lewis Road Park \$300,000
  - Soule Park \$358,400
  - Jose Flores CC - \$900K



# Rent & Fee Changes (1 of 2)

## Camping (Section II. Regional Parks):

- Camping and day fee increases for 8 of our 117 rate line items
- Remove reimbursement for overestimated vehicle counts (Sec II.A.4)
- Clarify cancellation fee policy such that the cancellation fee applies when cancelling greater than 48 hours before reservation
- Remove redundant language for 120 day stay (Page 9)
- Remove advanced payment clause for combining season stays
- Minor adjustments to Group Use Fee table

# Rent & Fee Changes (2 of 2)

## Community Centers (Sec VII)

- Community Center rates for “Business, educational and professional meetings changed to “Non-profit.” Non-profit definition added and rates reduced to \$10/hr. Rates for “Organized Instruction for profit” changes to “For profit.”
- \$20 charge for kitchen use fee removed for all community centers
- Community center fees are now all due at the time of reservation rather than 3 weeks prior.
