SUBJECT: Authorization for the Purchasing Agent or Designee to Increase or Decrease the Dollar Amounts of 18 Annual Service Agreements for Services Provided to County Agencies by an Increase of \$3,923,000 for Fiscal Year 2022-2023 for the Following Services: Facility Construction and Building Maintenance; Miscellaneous Services; Risk Liability Attorneys; Hazardous Material Disposal – Update #1.

## **RECOMMENDATION:**

Authorize the Purchasing Agent or designee to increase or decrease the dollar amounts of 18 purchase orders/contracts to cover projected usage through the remainder of Fiscal Year 2022-2023 for the following services: Facility Construction and Building Maintenance; Miscellaneous Services; Risk Liability Attorneys; Hazardous Material Disposal as set forth in Exhibit 1, which lists the revised not-to-exceed amounts, affected vendors, and types of services provided.

Prior to the start of the current fiscal year, the General Services Agency (GSA) Procurement Services Division reviewed existing contracts and agreements and held discussions with affected departments, as needed, to make projections concerning the demand for services and expenditure limits. Updates to the annual service agreement funding levels are requested when projections indicate that expenditures for a specific vendor will exceed approved limits. The current requested updates are set forth in Exhibit 1. All of the contract documents at issue were either approved by your Board or on forms approved by County Counsel.
