DISCUSSION:

As part of the initial Knox-Keene Act licensure process, your Board approved and authorized formation of the VCHCP Standing Committee to meet Knox-Keene Act public policy requirements, with authority to oversee the quality of care review system and grievance

process. The VCHCP Standing Committee meets quarterly. The VCHCP Standing Committee is comprised of the following as members:

- 1. Required by licensure
 - a. Ex officio members (by virtue of office):
 - A member of your Board, who serves as Chair. Supervisor Matt LeVere currently serves as Chair of the committee.
 - The Ventura County Executive Officer.
 - b. Appointed by your Board:
 - One plan provider
 - Four plan members
- 2. Required and appointed by your Board:
 - a. One plan provider member
 - b. Three plan member alternates.

All the re-appointments for consideration by your Board are County employees and VCHCP members. Both bring a wealth of knowledge and diverse experience. The Knox-Keene Act requires that all members of the Standing Committee be members of VCHCP.

The table below reflects the proposed appointment. Member terms are staggered to assure continuity of experience in the committee.
