The amendment modifies the payment structure for on-call perinatologist physician services from a monthly base of \$1430 to a daily rate of \$286. The total amount for call remains at 60 days per fiscal year up to the existing maximum of \$17,160 per fiscal year, pro-rated for fiscal year 2022-23 to 30 days and \$8580. The cost of these modifications are budget neutral and the services are included in the Fiscal Year 2022-23 budget.
