Make the following modifications to the bidding documents for subject project:

I. Alternate Date for Mandatory Prebid Meeting

A second alternate date is provided to fulfill the mandatory prebid meeting requirement in accordance with Section 01000-6 Pre-Bid Meeting. Alternate date is:

10:00 A.M. on Wednesday, January 4, 2023; at the Well No. 97 Facility; located at 9210 Stockton Rd, Moorpark, CA, 93020.

Contractor shall be required to attend at least one (1) mandatory prebid meeting held with the District.

II. Extended Bid Opening Date

The date for opening bids is changed from Thursday January 12, 2023 at 2:00 PM to Wednesday January 18, 2023 at 2:00 PM.

III. Notice Inviting Formal Bids

IV. Project Information

V. Specification Section 01000 GENERAL REQUIREMENTS

Add the following to the end of subsection 01000-6 PRE-BID MEETING:


"If a potential bidder cannot make one of the scheduled prebid meetings as listed on the Project Information form, for good cause as determined by the District Director, an alternate meeting may be scheduled at the sole discretion of District that will substitute for the mandatory one. The District is under no obligation to provide an alternate meeting or extend bid opening date as a result of."

VI. Specification Section 01000 GENERAL REQUIREMENTS

Contractor shall be responsible for contacting and negotiating with the owner, his or her designated representative, for its removal and/or modification/replacement by the Contractor; Contractor's bid includes the cost of this as part of their work.

2. *What is the kV rating of the power lines running across the site?*

Per Edison, the power lines are believed to be 16kV with the lower line being for communication wires. Contractor shall be responsible for confirming and abiding by all safety requirements related to.

Bids will be received, electronically, until **2:00 p.m. on January 18, 2023**, for **Well No. 97 Replacement**, Specification No. WW22-01, which consists of **construction of the drilling of a replacement well for Well No. 97 and the destruction of the original well**.

All Bidders shall be required to attend one (1) **MANDATORY** Prebid Meeting with the District. The following dates have been scheduled for this purpose: **10:00 a.m. on December 15, 2022** or **10:00 a.m. on January 4, 2023**, at the Well No. 97 facility, located at 9210 Stockton Rd, Moorpark, CA 93020. Bids must be submitted electronically, using the forms provided, on the Bonfire Website.

Subcontractor list must include a valid Contractor's License Number. Contractor and any subcontractors must be registered with the Department of Industrial Relations prior to bid time.

Each bid must be accompanied by a bid guarantee in the amount of not less than 10% of the amount bid, **PAYABLE TO THE PUBLIC WORKS AGENCY** and guaranteeing that the bidder will enter into a contract in accordance with the terms of the bidding documents if award is made. The bid guarantee shall be in one of the following forms: a bid bond written by an admitted surety insurer on the form included with the Proposal form, a cashier's check drawn by a national bank, a check certified by a national bank or cash. Bid bonds must be submitted in hard copy with the original signatures of the principal and surety. Copies of the completed bond will not be accepted.

Bidders must have a Class **C-57** California Contractors license. Upon award, the Contractor will be required to furnish a Performance Bond and a Payment Bond, each in the amount of 100% of the contract price.

In accordance with Section 22300 of the Public Contract Code, securities may be substituted for funds withheld.




