PROJECT DESCRIPTION: This is an appeal of the Planning Director's issuance of two Zoning Clearances. The Applicant requests that the Planning Commission issue two Zoning Clearances (Case Nos. ZC22-0937 and ZC22-0938) to certify that the re-drilling of two existing oil wells is authorized by a Special Use Permit (SUP) previously granted by the County of Ventura. The Appellant requests that the Planning Commission decline to issue the requested Zoning Clearances until environmental review is conducted (Appeal Case Nos. PL22-0152 and PL22-0153).

PROJECT LOCATION: Southwest of the intersection of East Wooley Road and South Rice Road. The subject wells are located between 1,000 and 1,700 feet from the boundary of the City of Oxnard, in the unincorporated area of the County of Ventura.
