RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA TO ESTABLISH "NO PARKING 9:00 P.M. TO 7:00 A.M." ZONES ON RANCH ROAD AND EDISON DRIVE IN THE CASITAS AREA

WHEREAS, Vehicle Code section 22507 and Ventura County Ordinance Code section 7021 allow local authorities to impose parking restrictions by resolution;

WHEREAS, The Casitas Springs Community Center (CSCC) located at 8437 Edison Drive is a community center in the unincorporated area of Casitas Springs between Ventura and Ojai, off Highway 33. This small center is part of the County's facilities that serves the public as a family designation venue for special occasions, recreation, and community gatherings;

WHEREAS, This area serves as school bus stop for children in the mornings. Individuals who have parked in this area over night or during the day have disposed trash, left human waste, and camp on the side of the roadway which can have a negative effect for those visiting the venue, including those who wait for the school bus;

WHEREAS, The County of Ventura General Services Agency Park Department and Host to the Community Center supports the requested no overnight parking zone given the legitimate concerns reported by local residents; and

WHEREAS, the installation of time limited parking restrictions to prohibit overnight parking will help resolve residents' concerns and will help achieve a safer, cleaner location for children, individuals, and families accessing the bus stop and community center;

NOW, THEREFORE, BE IT RESOLVED that, under California Vehicle Code section 22507 and Ventura County Ordinance Code section 7021, upon placement of appropriate parking signs, it shall be unlawful to park any vehicle in the following locations, from 9:00 p.m. to 7:00 a.m:

- On the west side of Edison Drive, from the Ranch Road centerline to approximately 190 feet south
- On the south side of Ranch Road from the Edison Drive centerline to approximately 240 feet west
- On the north side of Ranch Road from the Edison Drive centerline to approximately 240 feet west
