**Overtime** is equal to time-and-a-half of rate for applicable shift (based on a 40-hour week worked at Client facility) and will be billed based on hours worked over scheduled short hours. Example, if the CLS was scheduled to work a ten (10) hour shift, but worked eleven (11) hours, one (1) hour will be billed at the overtime rate. Overtime must be approved by the Client.

**Holidays:** Work performed on New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day will be invoiced at a premium Holiday rate of one and one-half (1.5) times the regular rate. Holidays begin 7:00 PM the night before the holiday, and end at 7:00 AM the day after the holiday.

**The following Conversion Fees apply to Direct Client Employment, as defined in Section 3.6 of the Agreement:**
