Subject: Authorization for the Auditor-Controller to Process the Necessary Budgetary Transactions to Decrease Revenues of \$3,250,000 and Revise the Funding Source for the Four Economic Vitality Programs Approved by Your Board from American Rescue Plan Act State and Local Fiscal Recovery Funds to General Fund - Assigned to Program Mitigation (Requires 4/5ths vote)

Recommendation:

1. Authorize the Auditor-Controller to process the necessary budgetary transactions to decrease revenues of \$3,250,000 and revise the funding source for the four Economic Vitality Programs approved by your Board from American Rescue Plan Act ("ARPA") State and Local Fiscal Recovery Funds ("SLFRF") as follows (requires 4/5ths vote):

Discussion:

On July 26, 2022 your Board approved of, and authorized the County Executive Officer to enter into, agreements with the Economic Development Collaborative and other vendor(s) to support the administration and implementation of four Economic Vitality programs (Exhibit 1). Your Board also authorized the Auditor-Controller to process the necessary budgetary transactions to establish the appropriations and revenues of \$3,250,000 of ARPA funding to implement these Economic Vitality programs.

The recommendation before your Board today requests authorization for the necessary accounting transactions to change the funding source for these Economic Vitality programs from ARPA to General Fund - Assigned to Program Mitigation. This is needed due to the recommendation approved by your Board on December 13, 2022, to use ARPA SLFRF under the Provision of Government Services.

On March 14, 2023 your Board approved the appropriation of approximately \$104M in funding towards the list of SLFRF projects. Since additional funding from General Fund – Fund Balance Assigned to Fiscal Recovery Projects will not be available until the end of this Fiscal Year 2022-23 when the remainder of SLFRF funds are transferred from Trust, funding from Program Mitigation is needed at this time as a bridge until such time funding from the Fiscal Recovery Projects account will be available. Therefore, it is requested that your Board approve this change in the funding source for the programs to be implemented as directed by your Board.

Projects Overview:

A full description of the four Economic Vitality programs, scope of work, and anticipated outcomes can be found in the Board Letter approved by the Board on July 26, 2022 (Exhibit 1). The four programs include:

	Childcare Technical Assistance and Capacity Building	\$360,000
	Fathomwerx Start-up Business Support	\$420,000
	VC Business Forward Enhancements and Outreach Program	\$250,000
