I request that the Board of Supervisors reject the proposal by Supervisors Parvin and Gorell which would repeal Ordinance 4510 in its entirety.

We request that the Board reject the proposal in **Item 44** to rescind current limits on campaign donations. If you can't reject it outright at your Tuesday meeting, we ask that you postpone voting until a second reading takes place. Many in the public know nothing about this issue. There needs to be more reporting and public comment before this Pandora's box gets approved.

First off, we very much appreciated and agreed with every word of Assemblyman Steve Bennett and Linda Parks' letter to the VC Star (https://sports.yahoo.com/guest-column-dont-let-supervisors-010020117.html) Their guest column is currently the ONLY source of information about this issue, as it hasn't been covered by the VC Star's reporters.

Their comment "Gorell and Parvin's stated rationale for repeal is that the local ordinance is not needed any longer since the state limits now apply to local candidates" reminded us of the SCOTUS argument in Shelby county v Holder - that the Southern states no longer needed federal oversight of their election laws. Yeah, no one believed that either.

On a macro-level: we are tired of all the grift caused by the excess of money in our elections.

We are tired of the corruption brought about by limitless dark money of billionaires and foreign governments brought about by Citizens United.

We are tired of fighting to make America a better, safer, and fairer place for all, only to be overwhelmed by relentless mega-million dollar campaigns that overtake all forms of media, smothering all opposition and bending the truth. Some examples:

On a state level: Prop. 22 - the fight to strip gig workers of benefits, cost corporations over \$224 million dollars. Many voters were horrified to find out that they were misled. It was ultimately declared to be unconstitutional. (https://www.nelp.org/blog/prop-22-unconstitutional/)

On a county level:

• Oil companies rebelled against your board's own eminently reasonable request that new drilling operations comply with modern standards, an issue that should have been moot if the companies involved were already in compliance. They forced it to the polls. Measures A and B, ordinances that would have upheld your ordinances, were killed by a \$8.2 million campaign by Aera Energy and Exxon Mobil, companies with international shareholders who aren't affected if an Oxnard farm, or drinking water is polluted. Environmental groups were able to raise just over \$1.1 million. Local activist Thomas Rebecchi said it was "'David-and-Goliath' battle, we're not gonna lie about it"

- The \$7.1 million difference in funding equals the influence of 9,466 separate donors at \$750 each. Measures A and B lost by about 6,000 votes.
- In 2020, California Resources Corp., one of the state's three major oil and gas production companies, contributed more than \$800,000 to support and oppose certain candidates for Ventura County's board of supervisors." The late Carmen Ramirez was one such candidate that was targeted.
 - \$800,000 equals the influence of 1,066 voters at \$750 each. (https://www.desertsun.com/story/news/politics/2020/02/19/california-resources-corp-oil-spends-big-ventura-supervisors-election/4766757002/)

We have some questions...

- A \$750 donation is already a lot of money for most people in Ventura County, where the average wage is \$56,058. At the average hourly wage of \$27, a donation of that size represents almost 28 hours of labor. Allowing that to grow to \$5,500, (203 hours of work, or more than the average \$4,671 made in one month) means that one wealthier person's influence becomes six times greater than what the rest of us can afford. Why can't they increase the fairness and equality of their messaging to grow their voting base, and their donations, by six times instead?
- Since, "kitchen-table math" seems so important to conservatives, why can't their candidates budget to the amount our local law allows? Ventura County government has a budget. If a candidate can't work effectively with their own campaign budgets, why should we trust them with a seat at the governing table?
- If local control is such an awesome thing for conservatives say, for school boards and such, why, on this one issue, do they want to use a state limit?
- Bennett and Parks' letter stated that Gorrell and Parvin implied that state law and the local county law cannot both apply simultaneously. This isn't true. Can you see that we are tired of being gaslighted?

Ventura County already have good laws and there is no reason to change. Maybe the state should look at our laws here and adjust theirs to match.

Dear Publicly Elected Supervisors of Ventura County,

Some of you may know me from my housing activism throughout our county, which has undoubtedly caused some discomfort among local elected officials, possibly including yourselves. I believe in adjusting regulations to meet the needs of the moment, so long as human safety, public health, and the environment are not compromised in the process. In housing, this translates to loosening overly restrictive regulations based on evidence of a need to increase the supply of housing that our communities produce. Politics is not housing – there is no need for limits on campaign contributions to be loosened as they are not constraining public participation in elections, except perhaps from those who stand to gain from the effects of increased contributions from wealthier supporters tilting the balance of a campaign in their favor.

What has come before you in this item is an attempt to loosen the County's self-imposed campaign contribution limits to match the much more generous limits that now exist under State law. Doing so would undermine the impact of individual contributions of up to \$750 that are currently within reach of a much larger percentage of Ventura County residents, and would instead allow those much higher earning individuals in the County that can afford to contribute \$5,500 per campaign to dominate local politics — quite likely in the pursuit of their own interests and at the expense of the other residents of Ventura County. Don't fall for it.

To those in the business community that have backed this agenda item as a means of gaining more political pull over the direction of the local economy – which I am sure is viewed as important to the ongoing viability of your businesses – I ask you to consider the longer-term implications of this proposal. There is a huge gap between what \$750 and what \$5,500 can accomplish in a campaign, and the political power you could buy with your own \$5,500 may easily be outbid by those with deeper pockets and more determination to influence elections than yourselves. This action will likely get out of your control at some future date and when that genie is out of the bottle you may regret imbalancing the political landscape for your perceived near-term gain. Instead, if you have evidence of local government regulations creating an onerous imposition in your ability to successfully do business in our communities, you should bring this evidence before our community governments and ask them to change the regulations.

Beyond these points to local elected officials and the business community, I must also add that it is not a good look before the public for you to support something that will so clearly take away their own political voice in local elections.

I urge you all to do the right and honorable thing.

Supervisors Jeff Gorell and Janice Parvin have placed on the agenda for the Ventura County Supervisors meeting on March 14th a proposal to repeal the Ventura County Campaign Finance Reform Ordinance which was passed unanimously on 25 April 2017 by then Supervisors Bennett, Parks, Long, Foy and Zaragoza. A complete repeal will seriously erode confidence in the integrity of County governance and its responsibility to the public of Ventura County.

The ordinance sets limits to campaign contributions in total and type, including prohibitions to activities as funds funneled through intermediaries, laundered contributions, money laundering and restrictions to bundled funds. Disclosures are required for contributions, advertising, payments for spokespersons and procurement of goods and services. Also defined is the Compliance Officer to investigate complaints and the Ventura County Campaign Finance Ethics Commission. Penalties are defined for noncompliance.

The current contribution limit of \$750 would be replaced by the State limit of \$5500 with repeal. The \$5500 limit is for counties that have not set their own limits but Ventura County currently has defined limits. A contribution of \$5500 is the amount that would equal the sum of 7-8 donors of \$750. Obviously, a candidate would prioritize the larger contribution instead of spending the effort to attract a larger number of smaller donors. Plutocrats and corporations would be targeted by the campaign and these contributors would gain influence over County Government as a result. The needs of the public exclusive of the well-heeled minority would be neglected or ignored.

Undoubtedly the State of California has standards and regulations concerning campaigns but anyone who has dealt with State agencies is aware of responsiveness and cumbersome processes involved.

The Ventura County Supervisors should keep the current ordinance in place. We would like to be known as a bastion for democratic republicanism not for corruption and cronyism.

While I understand the desire to alter the current fundraising limit from \$750 to some increased level of contribution, it does not seem necessary to eliminate the entire ordinance to implement a change in the contribution limit.

The repeal proposers refer to state statutes that would govern in the absence of the existing county ordinance however I believe it is important to maintain oversight at a local level. The Board of Supervisors has significant influence on the development and use of county resources that most directly affect our local communities.

The repeal proposers indicate there is a necessity to rely on Independent Expenditure Committees to supplement campaign marketing efforts because of the \$750 contribution limit. I would prefer to see an amendment of the existing ordinance to require full disclosure of all funding for Independent Expenditure Committees. Though these committees are presumably not "coordinating " with the candidate's election committee, that cannot be confirmed because there is insufficient transparency into the funding and activities of these outside committees.

For the last 20 years Ventura County has had one of the most effective campaign reform laws in the State of California. While we have not eliminated the influence of big money in our county elections, we have significantly limited it. We empowered local citizens' voices in elections by limiting campaign contributions to \$750.

I am writing to express my indignant opposition to the latest move to strip us of our protections. This coming Tuesday, March 14th, Supervisors Gorell and Parvin are proposing to eliminate the County's campaign finance ordinance and all of its protections. Most disturbing, contribution limits would rise from the \$750 local limit to the \$5,500 statewide limit.

Allowing the limits for donations to grow from \$750 to \$5,500 for county supervisor races is not good government for Ventura County. One couple will be able to give \$11,000. The average citizen's voice will be drowned out by big money donors. Connection to those donors rather than grassroots supporters will be the focus of far too many county candidates.

Gorell and Parvin unconvincingly state in their letter that influence buying will not be an issue because a new state law states you cannot vote on a project if you have received a donation of more than \$250 from an interested party in the previous 12 months. Imagine how easy it is to get around that restriction. Make your big contribution early in a candidate's election cycle, even well before they are elected, and then be sure your project or issue arises 12 months after your donation. Easy to do.

They imply that state law and the local county law cannot both apply simultaneously yet that is exactly what 25 counties in California currently do, including Ventura County. If you care about decreasing the influence of big money in politics, you should support lower state contribution limits and continue the benefits of having the restrictions of both state and local laws in effect in Ventura County.

The arguments for repealing our important campaign ordinance do not reflect the standards and values we have set for ourselves for the last 2 decades in Ventura County.

Most of our citizens have valued making Ventura County a special place in California, far better than the state average. We are better at stopping urban sprawl, better at limiting the influence of big money in politics, better at enhancing the influence of the average citizens over special interests and better at protecting the most disadvantaged because we have reduced the influence of those most inclined to ignore them.

Repealing our current law, removing the \$750 contribution limit, reducing transparency and ending the expenditure limits will significantly increase the amount of money flowing into county supervisors' campaigns. It will give big rollers much more direct influence on Supervisors.

For 20 years we have significantly decreased the influence of big money in our elections for county supervisor. It all could be lost by three votes this coming Tuesday, March 14th, at 10:30 in the Ventura County Board of Supervisors hearing room.

As a long-time resident of Ventura County, I oppose this wanton destruction of our way of life.

The proposed repeal of the entire Ventura County Campaign Finance Reform Ordinance (Article 6 of Chapter 2 of the Ventura County Ordinance Code) fails to do what its sponsors suggest it will do. It fails to promote public trust, fails to protect the individual voter, and fails to prevent individuals or organizations from using their financial strength to allow them to control or unduly influence elected officials.

Repealing this ordinance would increase the limit of campaign contributions from \$750 to \$5,500, an amount seven times higher all at once. This would give special interests a huge unfair advantage over the ordinary Ventura County resident, especially those who reside in the two designated minority majority districts. Raising the contribution limits would not eliminate independent expenditure committees and the problems they pose as implied in the letter submitted by Supervisors Janice Parvin and Jeff Gorell dated March 14, 2023. Instead, it would compound the problems.

This repeal would cede local control of our election laws to the state. The County of Ventura should not simply repeal its own specific finance campaign reforms because 33 other counties have decided to follow the State's requirements without understanding the specific differences and needs of Ventura County and the concerns of its residents.

At the very least, the public should be allowed more time to better understand the consequences and impact of this proposed action. The public needs more than a two weeks to understand how this action will impact them.

This is not a simple amendment of Ventura County's campaign finance laws. This is instead the wholesale elimination of an entire County ordinance that the public has relied upon for election transparency and fairness.

Therefore, we request that the Board of Supervisors delay its action on the proposed repeal for at least 60-90 days to provide the people of Ventura County adequate time to better understand whether or not this repeal is in their best interests.

Dear Board of Supervisors: The item before you Tuesday has a long and important history in our county, for our voting residents, and for the sanctity of empowering grassroots political leaders. As a signer to the original ordinance, I recall the due diligence put into reviewing FPPC rules, along with legal council discussions. Tremendous effort was put into developing a fair ordinance in response to the public's demand for campaign finance. Key efforts to establish accountability and transparency for the public good was the foundation for the ordinance.

The public knows that self-financing and independent expenditure committees can create a serious disadvantage in campaigns. This proposal before you to repeal the local ordinance relying on the state guidelines, goes further to eliminate both the foundational principles of accountability and transparency. Having dealt with the FPPC rules, they typically take more time than the election cycle to review complaints, sometimes months after the election is certified. Additionally, the existing ordinance requires timely posting/transparency of contributions right up to within 24-hr time at certain dollar levels. This would be eliminated. These were purposeful rules in the ordinance to create fair campaign practices.

And yes, money/campaign funding does buy influence at these high levels of individual contributions. You have many other options: raise the individual contributions based on local analysis of local ordinances; and keep the transparency guidelines to assure the public trust.
