We are writing in opposition to the proposed Repeal of the Ventura County Campaign Finance Reform Ordinance. The intention of the Ordinance put in place in April of 2017 as stated was to "reduce the appearance of corruption, and to prevent individuals or organizations from using their financial strength to corrupt Ventura County government by creating political debts through contributions or expenditures that allow them to control or unduly influence elected officials.."

This proposal by two current Supervisors, suggests we change the current maximum level of \$750.00 to the State level of \$5500.00 per individual per candidates election cycle. The basic reasons stated are that Ventura County do what other counties are doing and that there has been a cost-of-living increase.

We suggest that for most working-class people, a high per centage of Ventura County workers/voters, Policemen, Teachers, Construction Workers, Firemen, Retail Workers, etc. \$5500.00 per person is a very large amount to donate compared to their income. This would mean residents of great wealth would have the ability to donate a large percentage of money to local campaigns, certainly raising questions of influence.

Candidates for county offices have been able to raise large amounts of money under current restrictions. Supervisor Gorell raised over \$210,000 according to the Ventura Star in the last election. As stated in the proposal, this does not include other forms of campaign money, weather it be from the candidates own money or other political organizations. Candidate Parvin even had political ads on television.

For the sake of transparency and the idea that all citizens have an equal voice in government, especially at the local level, we request The Board reject this proposal.
