Re: <u>Agenda Item 50 - Second Public Hearing Regarding Adoption of an Ordinance</u> <u>Amendment for Ventura County Campaign Finance Ordinance</u>

We the undersigned, representing 16 organizations serving Ventura County, object to the repeal of Ventura County's Campaign Finance Ordinance, Agenda Item 50.

Ventura County is experiencing an alarming increase in the amount of special interest money in local elections. In last November's election, more money was spent on the Supervisors race by Independent Expenditure Committees than by candidates. The stated fix by Supervisors Gorell, Parvin, and Long is to "even the playing field" by increasing the amount candidates can raise and spend. This is cynical at best.

By repealing Ventura County's campaign finance ordinance there is only one predictable

outcome: more money will be spent and more influence will be gained by special interests. The repeal will also disband the County's Ethics Commission and remove restrictions on when Supervisors can take money. It is a step backward for clean money, transparency, and democracy.

We know controversial decisions by the Board of Supervisors often pit the few who stand to gain financially against the many who support the environment, clean water, clean air, public health, and social justice. We also know money talks. The campaign finance ordinance was necessary because developers were contributing tens of thousands of dollars to candidates for Supervisor. That is why the Board of Supervisors reined in big money in candidate campaigns.

This repeal is being proposed without any analysis from County staff or Commission on the impact of removing the individual contribution cap and the removal of expenditure limits and time frames for collecting contributions. This brash recommendation is not informed by sound analysis and fails to address economic, social, and decision-making process impacts.

We urge you to uphold the public's trust and side with the vast majority of Americans who want less, not more money in political campaigns.

It is no secret that money can swing elections. It is interesting to me that three of our current Ventura County supervisors are attempting to get rid of Ventura County's Campaign Finance Reform Ordinance whose stated purpose is to "Promote public trust in Government institutions and the election process, (and) reduce the appearance of corruption and prevent individuals and organizations from using their financial strength to corrupt Ventura County government...." This ordinance certainly seems like a good and important addition to our local elections.

Supervisor Long has made some unfortunate decisions that mean she is facing a tough battle in her district. Voting to allow drilling adjacent to Lemonwood was an unpopular choice in Oxnard, except for those who work in the oil industry. Is it a coincidence that Supervisors Long, Gorell and Parvin now wish to take away one of our safeguards to free and fair elections during a time when many conservative politicians are realizing how unpopular their platforms and voting decisions are with the public? Dear Members of the Board of Supervisors:

On March 14th I asked you to keep Ordinance 4510 in place and reject the proposal to repeal it in its entirety,

I asked you to not insult the voters' intelligence with your highly speculative, implausible and laughable arguments initially offered by Supervisor Gorell and Parvin. On March 14th, you did much worse.

Supervisor Gorell, you said that you and Supervisor Parvin began your conversation to explore how to change the current ordinance, but you quickly pivoted to specious reasons why you and she favor repealing the ordinance in its entirety. You offered no information, if any is to be had, of what amendments you and she considered bringing forward.

You and Parvin say that "we've been lazy as a county" in monitoring and adjusting the contribution limit for the impacts of inflation and the cost of living and that "we don't have the ability at the county level" to do that. Well, since 2001 the County took on this obligation and responsibility when it adopted its Living Wage Ordinance.

You and Parvin complain that people must track campaign donations for different offices on different website and that "people don't understand there's a difference". I find this statement most insulting to us voters!

AB 571 provides for local control, something I've heard each of you argue for in other circumstances. We hear what you say but we see what you do. You have heard overwhelmingly from your local constituents that we favor local control in this matter and support for our current ordinance.

Ventura County is special for many reasons, one of which is that we value the efficacy and integrity and fairness of our local electoral process. Help keep our elections open, transparent and fair. Reject the proposal to repeal Ordinance 4510 in its entirety.

Attention Chair LaVere and Supervisors:

I request that campaign finance contribution remain capped at \$750/individual, and not be raised to \$5,500. Further, a thorough staff analysis should be finalized to inform the decision and to ensure safeguards remain to limit the improper influence on candidates and elected officials. The ordinance should be amended to bolster strong disclosure and enforcement regulations, which are critical.

It has been especially disconcerting to see special interests and political donors in support of the oil and gas industry dominating financing in recent Supervisor races. Even more so, watching supervisors vote according to special interest priorities. It appears improper influence is afoot, and the interests of Ventura County residents as a whole are playing second fiddle to Oil and Gas profits.

The Brennan Center for Justice's sanalysis and reporting has proven that dark and gray money has surged in state and local elections. Decreasing from 76% transparent funding in 2006 to only 29% in 2014, since the *Citizens United* decision. "Donations from dark groups to super PACs increased 49 times in these states (including California) between 2006 and 2014, from less than \$190,000 to over \$9.2 million." Gray money via non-profits has ballooned to nearly 60% of all outside spending in 2014. Notably, "dark money in state and local levels frequently flows from special interests with a direct and immediate economic stake in the outcome of the contest in which they are spending, in contrast to what is often portrayed as the more broadly ideological outside spending at the federal level."

Lower costs make it easy for special interests to dominate state and local elections. Dark money even outspent candidates themselves, with amounts as low as \$100,000 or \$10,000 which is modest for corporations versus the major hurdle it is for many candidate and community groups.

As an environmentalist and mother of young children growing up in Ventura County, we must support a just transition away from fossil fuels to sustain a livable planet and prioritizes the health and safety of our citizens, and protect our local water supply which is mainstreamed in every sector of our economy.

The vast majority of wells in Ventura County are idle, orphaned, or not operational. To cap and transition away from oil and gas to renewable and clean energy would actually create more jobs locally. These special interests are buying votes to not fulfill their legal obligations and are leaving taxpayers in the county and statewide with the check for their improper closure. The oil and gas industry opposes any and all regulations that hold them accountable for their impacts on the environment. It's unconscionable and immoral. Remediation, mitigation, and regulations are a cost

of business, for a thriving County. These special interests seek only to benefit, and not address the harm they create while doing so. Regulatory power at the Board of Supervisors is concentrated and directly impacts Oil and Gas's bottom line, which is why they are targeting local elections.

Big money should have no place in our local politics. By increasing the cap on campaign finance, we will remove the guardrails that protect our democratic system and environment, unless Supervisors refuse to take special interest funding. By increasing the cap, you will only enable a stronger foothold for these special interests.

Please oppose this increase, undergo a more thorough review of the implications; as only a few are highlighted here, and bolster the current disclosure language to deter black and gray funds from entering our local politics any further.

As I understand the situation, Supervisors Gorell and Parvin have stated the rationale for repeal is that the local ordinance is no longer needed, since the State limits now apply to local Ventura County election candidates. As I stated last week and agin state now for the record, I disagree with this perspective for the following concerns and reasons:

- Allowing the limits for donations to grow from \$750 to \$5,500 per donor for County Supervisor election campaigns could be a serious threat to good government for Ventura County. A well-to-do couple would be able to donate \$11,000...significantly well above the \$1,500 local limit currently in effect.
- Such a rise in the donation limit amount could work against the average citizen's voice, since for them making comparable donations at the higher levels would most likely be much more difficult, thus threatening to reduce fair and equal campaign voicing by the broadest possible percent of Ventura County residents.
- Such a situation could grant an unfair advantage to larger privileged donors, putting grassroots supporters at an unreasonable and unfair disadvantage.

As a 37 year Ventura County resident who made my career here, this clearly does not align with the Ventura-way of doing business. The concerns of the local working- and middle-class residents need to have an equally effective voice with those of larger and more wealthy residents and business interests. Any such action of this nature should be placed on the ballot for a vote by the citizens of Ventrua County.
