ORDINANCE NO. 4616

AN ORDINANCE OF THE COUNTY OF VENTURA REPEALING
THE VENTURA COUNTY CAMPAIGN FINANCE REFORM ORDINANCE

The Board of Supervisors of the County of Ventura ordains as follows:

Section 1. Repeal of the Ventura County Campaign Finance Reform Ordinance.

Article 6 of Chapter 2 of Division 1 of the Ventura County Ordinance Code entitled "Ventura County Campaign Finance Reform," as codified in sections 1261 through 1307 by adoption of Ordinance Nos. 4510 and 4546, is repealed in its entirety.

Section 2. Effective Date. This ordinance shall take effect thirty (30) days after its adoption. Once effective, state law will govern and the "Ventura County Campaign Finance Reform Ordinance" set forth in Article 6 of Chapter 2 of Division 1 of the Ventura County Ordinance Code will no longer be in effect nor apply to campaigns for the following elective County offices: Assessor, Auditor-Controller, Board of Supervisors, Clerk-Recorder, County Superintendent of Schools, District Attorney, Sheriff, and Treasurer-Tax Collector.
